



## **GagaEden Terms & Conditions**

### **Programming**

- Gaga has the right to amend the course's schedule and the teaching team.

### **Visas**

- Gaga cannot sponsor or assist with any visa. The participant is fully responsible for securing any necessary visa in order to travel to GagaEden.

### **Insurance and Liability**

- The participant is aware that participation in the course, during classes or other activities organized by Gaga, can bring risks. Participation in the course is on a voluntary basis and for the risk of the participant. Gaga does not accept any liability for any material or immaterial damage (injuries, matter damage and possible consequences of damage included), irrespective of its cause.

- Gaga must be informed in advance by the participant about any past or present injuries. Failure to report medical issues, as well as other issues that concern a participant's well-being, is at the risk of the participant. Participants will be required to submit a health statement prior to the start of the course.

- Any medical problem that causes difficulties in dancing and hinders the active participation in classes has to be communicated clearly to the teachers.

- Participants are obliged to provide for their own health and liability insurances and provide proof if requested by Gaga. Without the proper insurance, the participant cannot participate in the course.

- Participants are advised not to leave any valuable personal belongings in the dressing rooms or other public areas of the facilities. Gaga is not liable for damage and/or theft of personal belongings.

### **Permissions**

- Participants are aware that the activities of the course can be photographed or can be recorded on video for publicity purposes of the company. Participants cannot, under any circumstances, claim right of property regarding these materials. Participants will submit a photography consent form to this effect prior to the start of the course.

- Participants are not permitted to take video recordings and/or photographs of the classes.

### **Cancellation Policy**

- Gaga has the right to cancel all activities of GagaEden in case of insufficient enrollment (up until one month before the start of the program) or force majeure. Received tuition payments will be refunded in full to all participants. In case of such cancellation, Gaga cannot refund any invested travel expenses or international financial transaction costs.

- If you cancel up until 1 month prior to the start of the course: you will receive a refund minus 380 ILS.
- If you cancel between 1 month and 2 weeks prior to the start of the course: you will receive a 50% refund.
- If you cancel within 2 weeks of the start of the course: there is no refund.
